In 2012, the brand SWISSCARE™ was exported and SWISSCARE™ Insurance Services (Singapore) Pte Ltd. was established. This company aims to serve Asian clients with insurance plans under the SWISSCARE™ brand.

The year 2013 was an exciting year in terms of developing business and brand marketing for SWISSCARE™. In order to provide health insurance benefits to expatriates, SWISSCARE™ Services Ltd. (LI) was incorporated in the Principality of Liechtenstein. The company is licensed under the nr. 10095 as an insurance provider/broker by the FMA financial market supervisory authority of Liechtenstein.
